I, Sonam Jain, Company Secretary, have been appointed by the Board of Directors of Yash Trading and Finance Limited ("Company") as Scrutinizer for the purpose of:

- i. Scrutinizing the remote e-voting process in terms of the provisions of Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended (Rules) and
- ii. Voting by Shareholders at the 33rd Annual General Meeting (AGM) held on 28th September, 2018 ("AGM") for all the resolutions contained in the Notice of AGM.

I pleased to submit my report as under, which is comprehensive and self- explanatory in all respect:

1. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and the Rules relating to remote e-voting on the resolutions contained in the Notice of the AGM of the members of the Company and at the meeting. My responsibility as a scrutinizer for the voting process is restricted to make a scrutinizer's report of the votes cast "in favour" "against" or remain "abstain / invalid", if any on the resolutions contained in the Notice of AGM, based on the reports generated from the e-voting system provided by National Securities Depositories Limited (hereinafter "NSDL") and based on the voting conducted at the AGM.
2. The Company has completed the dispatch of Notice of Annual General Meeting along with the Annual Report of the Company as on 6th September, 2018 to its members whose names appeared on the register of Members/ List of beneficiaries.
3. Advertisement was published by the Company in English in Free Press Journal dated Friday, 7th September, 2018 and in Marathi in Navshakti dated Friday, 7th September, 2018.



2018. The notice published in the newspaper carried the required information as specified in Sub Rule 3(v) (a) to (g) of the said Rule 20.

4. The Company has availed services of National Securities Depositories Limited (hereinafter "NSDL") as the agency for providing the remote e-voting platform.
5. The Voting rights were reckoned as on Friday, 21st September, 2018, being the cut-off date for the purpose of deciding the entitlements of members at the remote e-voting and voting at the Meeting.

The remote e-voting results on the NSDL E-voting platform were unblocked and downloaded on Friday, 28th September, 2018 in the presence of two witnesses Ms. Richa Jain and Ms. Dinky Jain, who are not in the employment of the Company and who have signed below in confirmation of the votes being unblocked in their presence.
8. On scrutiny, I report that 09 Shareholders were present in the meeting in person.
